9.5 Jubilee Pond

Mr J Mansall gave a short report:

- The island to be repaired/replaced – the Clerk to contact Mr S Hardcastle
- Some footpath pavers need to be made safe
- Risk assessment to be carried out in the spring

The parish councillors involved with the setting of the base for the new bench plus the two benches on the B1230 Wallingfen Way were thanked for their hard work and the parish councillors were thanked in advance for their hard work setting the three benches in the next few days.

9.6 Play Area

Mr J Jessop to contact the members of the action group to see what, if any, progress has been made regarding funding etc for a new play area.

10. WALLINGFEN WAY PROJECT

The Clerk reported that the Wallingfen Way Project was now complete with the installation of the three benches. The Clerk to contact the family (regarding the Greenoak junction) about the parish councils invitation to use the area near to the bench (and not the road sign) to place flowers in memory of their daughter killed some years ago at the site. A small piece of land can be licensed to the parish council by the ERY Council to create a small garden next to the bench or the family could decide to provide their own planter – the small garden and/or the planter to be planted out seasonally.

Unfortunately the allowance with LEADER for the Wallingfen Way was not enough to enable the parish council to have brick/stone village entrance signs designed and created. The Clerk to take on the task of acquiring labour, designs and materials to either a very tight budget using any finances left underspent in the budget or sponsored or volunteered.

#### 11.FLOOD PREVENTION - PHASE 1 – LAND

Mr P Robinson and Mr N Norris to contact Heptonstalls regarding the proposal for the parish council to, in some way, take over the responsibility of the strip of land now over the refurbished land drain – Chestnut Drive/Scalby Lane. The land is owned by HORNCastle GROUP.

#### 12.FLOOD PREVENTION – PHASE 2/3

Work Phase 2/3 is continuing although at times is hampered by the bad weather.

Some election campaign information passed around the parish for the recent by-election claimed the parish councillor resigned because of lack of freedom of speech. The actual letter of resignation was presented and clearly states the resignation was through ill-health. The Chairman called for a line to be drawn under the whole ‘shoddy’ affair and that the parish council moves on and continues its work for the parish as a whole.

#### 13.HIGHWAYS

The parish council has received a complaint from a resident regarding the parking of at least 1 vehicle on Sandholme Road which causes poor visibility for other road users. The Clerk has contacted the police and the Highways department at the ERYC. Mr P Robinson and Mr N Norris to contact the vehicle owner, informally, explaining the situation.

The Clerk to process the grant application for winter maintenance, via the ERY Council, for both Gilberdyke and the cemetery (Joint Burial Committee) at Newport.

8.3 Parish Plan

It was resolved to put the printing of the parish plan with Beverley Printing at £850.00 ex vat. It was resolved that Mr N Norris will progress the completion of the parish plan printing.

8.4 Play Area

The recent report via the ERY Council for the plan area has been received and circulated. It was resolved for the Clerk to leave the report and recommendations with A Nicholson for the small number of tasks to be completed.

8.5 Jubilee Pond

It was resolved for the Clerk to contact Mr S Hardcastle regarding the pond island and for the Clerk to also obtain quotes for repairs necessary to the paved pathway at the pond.

9.WINTER MAINTENANCE

All members present agreed that the deployment early of the snow plough was a success but it was felt Gilberdyke roads should perhaps be cleared before Blacktoft Parish to ensure the main roads are cleared for everyone to be able to use mainly because a large area of roadway in Blacktoft parish is on the precautionary gritting route.

The parish council to consider the purchase of a small pathway gritter: purchase and storage of salt/grit.

The Clerk to prepare a map of the pathways in the parish and village for clearing.

10.FLOOD PREVENTION – Phase 1 – This phase is more or less complete. A meeting to be arranged with the solicitors regarding the future of the strip of land over the newly refurbished land drainage system.

11.FLOOD PREVENTION – Phase 2/3 – This phase has started but has been held up because of utilities. The Clerk to contact ERY Council, Internal Drainage Board and the Contractor to have the situation clarified.

2.CONFIRMATION OF PREVIOUS PARISH COUNCIL MEETING MINUTES –  
resolved to be signed as a true record.

3.JOINT BURIAL COMMITTEE MEETING MINUTES – received and noted. There  
are some changes to the information in the rules and regulations of the cemetery prior to  
publishing.

4.GILBERDYKE RAILWAY STATION

Mr Chris Goodwin from NETWORK RAIL as a guest of the parish council discussed the  
problems, concerns and future developments regarding the public using the railway  
station platform as access to the ERY Council public right of way over the railway lines  
to the west of the site.

A site meeting with Mr C Goodwin and Mr J Jessop to be arranged.

The proposal to create a new footpath from the railway station car park to the public right  
of way and creating a footbridge over the dyke is to be investigated. The Clerk is to  
contact the Internal Drainage Board and the Public Rights of Way officer at the ERY  
Council for their assistance and opinions.

Costs to be considered and possibly will be shared by the rail authorities and the parish  
council.

#### 4.GILBERDYKE RAILWAY STATION contd.....

Other points raised:

- Dog fouling in areas where railway employees are expected to work
- Trees on the embankment which need felling and removing
- Fencing the embankment south of the bridge for a safer play space for youngsters – this has been investigated in the past and will be investigated in the near future but up to date the feasibility of the project prove to be very expensive
- Styles over the rail crossing at the public right of way in need of some repair

Mr C Goodwin was thanked for attending the parish council meeting.

#### 6.PUBLIC PARTICIPATION

The following items were brought to the attention of the parish council by Mrs L Cotton and Mr G Cotton:

- Rubbish in the village in the vicinity of the demolished Railway Hotel and Jubilee pond (fly tipping) – the Clerk to report the fly tipping to ERYC and RAILTRACK
- The island at Jubilee Pond – it was confirmed that the work needed at the pond is in hand
- There is a problem with dog waste in the village
- The children's play area footpath is breaking up – the parish council confirmed that it is aware and the path will be repaired in due course. The parish council is working against the list of tasks revealed in the recent annual play area inspection
- Glass recycling – this is the responsibility of the Memorial Hall Committee not the parish council
- Car mechanic – junction of Thornton Dam Lane and the B1230 (Wallingfen Way) – the parish council confirmed that as yet no further action can be taken by the parish council as it is now the responsibility of the E R Y Council
- Rubbish and litter on the playing field – it was confirmed that the playing field is the responsibility of the War Memorial Hall committee not the parish council
- Notice boards and parish council agendas. The Clerk confirmed that there are 3 notice boards – post office, Memorial Hall and medical centre: all are old stock and are maintained annually but there is no budget for complete overall or replacement in the current or the next financial years. The Clerk also gave a short explanation regarding the publishing of the Agendas but for information the following is included in the minutes:

## 6.PUBLIC PARTICIPATION contd.....

### Public Notices and Agenda

At least 3 clear days (not including the days of issue and meeting) before a meeting of the council A notice of the time and place of the meeting must be affixed in some conspicuous place in the locality. The Clerk is responsible for the notice but some councils just post a full years list of meeting dates at the beginning of the year. The Clerk is also responsible for inviting the press to attend meetings.

A similar period before the meeting a summons, signed by the Clerk, must be left at or sent by post to the usual residence of every member (not the public or press) of the council. This must specify the business to be transacted. Gilberdyke receives its agendas (and draft minutes) 7 days before a meeting usually by email as agreed or by post or hand delivered but copies of both agendas and minutes are available at the meeting. Confirmed minutes can only be handed out to the members of the public and press.

The Clerk is responsible for the content of the agenda - not the public, nor the members - unless a specific request is made by a member well before the agenda is published (Standing Orders).

There is no legal requirement for the parish council to publish the agenda BUT members of the public can request a copy at the meeting.

It is becoming a common practice to send agendas (and other documents) by email. Whilst this may be a helpful practice it does not comply with the statutory requirements of service and cannot lawfully be used as an alternative to delivery in person or by post. The Clerk has no objection to providing a copy of the agenda to members of the public but it will only be 3 days before the meeting - by post and hardcopy to be paid for as per the FOI.

Gilberdyke gives far more information to the members of the public than it is required to do.

Websites are not compulsory and are purely at the discretion of the parish council. The content of the website is also purely at the discretion of the parish council.

## 6.PUBLIC PARTICIPATION contd.....

It should, however, be noted that the first point of contact for any parish council is the Clerk for all information including agendas, minutes etc. and not the website or individual members of the parish council.

Mrs J Bate noted that the ERY Council gritted the access route to the tip during the recent bad weather.

Mr J Jessop - as a member of the public – will be contacting the Environment Agency and the Ombudsman regarding what is thought to be maladministration by the ERY Council.

### 10.1 GDLA

Mrs J Bate reported – that the groups are busy and successful but the administration side of the G D L A is struggling with not enough volunteers.

Mr A Wilson to be the new parish council representative on the G D L A.

10.2 Memorial Hall

Mr N Norris gave a short report – there have been some successful fundraising especially the recent Bingo sessions.

Mr J Jessop reported that there is a litter problem at the site – car park and field but this is being addressed.

The Puddleducks and Toddler groups are to move into the annex and a small fenced area to be provided for outdoor play.

A small financial grant has been received for fencing from DRAX.

The Clerk reported on the NO DOGS ALLOWED signs for the playing field. Apparently the field is not included on the ERY Council Dog Control Order – the Clerk to contact the ERY Council requesting the area is placed on the control order list and to repeat the request for dog signs.

10.3 Play Area

Mr J Jessop reported that the play area group have been in contact with a new equipment company which offers a design service at a cost of £150. The parish council resolved to contribute to the charge.

10.4 Parish Plan

Mr N Norris reported that the plan was ready to print as soon as payment was received from the parish council.

10.5 Parish Paths

Mrs D Longhorn to have a meeting with the ERY Council officer regarding the long outstanding DUCK WALK at the railway pond.

10.6 Market Weighton Canal

The Clerk gave a short report regarding the first meeting of the steering group discussing proposals to improve maintenance, facilities, connections and wildlife of the area surrounding the canal.

10.REPORTS contd.....

10.6 Market Weighton Canal contd.....

Representatives attending included Market Weighton Internal Drainage Board Clerk, Yorkshire Wild Life Trust, Newport Parish Council, Broomfleet Parish Council, Holme on Spalding Moor Parish Council, Blacktoft Parish Council, and Gilberdyke Parish Council but the wider group will also include the Market Weighton Canal Society, ERY Council, Hotham Parish Council and North Cave Parish Council.

Newport Parish Council will manage a budget of £8,500. Administration is budgeted at £500 with the remaining £8,000 to be used to hire a consultation group to bring ideas into the steering group for the improvements to the length of the canal.

Tenders for the consultations have already been advertised and the next meeting of the steering group will be May 2012.

The parish councillors are invited to give any ideas and thoughts regarding the project to the Clerk.

10.7 Jubilee Pond

The Clerk reported that Mr S Hardcastle suggested the cost of replacing the island would be too much for a budget of £350 and asked if the island is necessary. The Clerk to contact Mr S Hardcastle once more and request some of the edge boards be repaired and the island to be reconsidered at a later date.

10.8 Wallingfen Way Project

The Clerk reported that the project has finished but repayment of the costs to the Parish Council were still to be made.

10.9 EYMS

The Clerk to contact EYMS regarding the possibility of placing a bus stop at the Cross Keys east bound – opposite the bus stop west bound. This would make it easier to ensure a bus is caught rather than missed because of the confusion regarding the two different bus routes though Gilberdyke.

10.10 Village Signs

Mr C Newsome reported that some very large pieces of locally quarried stone may be made available to the parish council for 3 village signs. The signs could have GILBERDYKE carved into them or the metal GILBERDYKE signs could be used.

The Clerk to contact ERY Council regarding the possibility of using such large pieces of stone.

The Clerk reported that the Hull College had been approached regarding students carrying out the brick/stone work on village signs.

## 6.GILBERDYKE RAILWAY STATION/FOOTBRIDGE/EMBANKMENT

Some points discussed:

- It has to be agreed where footpath for access is sited and who is responsible for the footpath and who is responsible for the financing of the footpath

## 8.FLOOD PREVENTION PHASE 1 AND 2/3

The parish council is concerned that information coming in contradicts comments from the ERY Council and the contractors.

It is felt by the parish council that the ERY Council could have better communication with the residents.

Other points raised:

- Pumped water from the works on Station Road ran the length of Greenacre Park/Chestnut Drive ó which might show the road drains are not clear or capable of taking water in large amounts
- Some residents are upset regarding the storage cages for equipment being placed outside their properties. It is noted that the ERY Council is responsible for this section of the drainage system.
